Corporate liaison visits in Stavanger region to both companies and banks. (Project 7081). Norwegian aquaculture delegation attending AQUACULTURE INTERNATIONAL in Canada. Developing downturn in Norwegian economy has led to tightening up of capital available for overseas expansion of Norwegian industry. However, several oil and gas firms are actively pursuing joint ventures in Canada related to Hibernia dvlpmt. Stavanger banks also expressed some potential interest. Nrwgn delega'n to AQUACULTURE INTER'L identified sev. opportunities for dvlpmt with growing interest in Canada's East Coast.
