#### Hon. Mr. BALLANTYNE:

1. In so far as the Harbour Commissioners of Montreal are concerned, the practice of

previous years is being followed. Practically all of the commission's employees are residents of Montreal with the exception of those employed on tugs. The latter are in large part recruited in Sorel and other points along the St. Lawrence river.

### Hon. Mr. BURRELL:

1. \$7,000 a year.

2. Building was rented as accommodation for Dispersal Station Military District No. 6, and to be used in case of emergency due to transportation difficulties. It has been occupied by the following units: 485 men 1st Depot Battalion, British Columbia Regiment, 27th April to 14th May, 1918. 49 men 12th draft Canadian Field Artillery, British Columbia Regiment, 27th April to 14th May, 1918. 355 men 12th draft, 2nd Battalion, May 8 to May 14, 1918.
