not be disappointed, that my strong impression that it is unlikely that the documents called for by this motion will be procured. If the hon, gentleman reflects a moment he will realize that the Department of Justice has no direct communication with the provincial courts in the administration of justice. All the records of those courts are provincial records and we do not get reports of that character.

Motion agreed to.

W. H. TAPLEY AND E. L. BAUGH.

On the order for the motion:

Mr. CASGRAIN:

For production of copies of all letters, telegrams, papers, documents and correspondence in reference to the release from penitentiary of one W. H. Tapley and one E. L. Baugh.

Rt. Hon. C. J. DOHERTY (Minister of Justice): It is impossible to assent to the passing of this resolution. It is very well recognized in the House that correspondence with regard to applications for tickets of leave is of a confidential nature and is not to be brought down. There are numerous instances in which the matter has been brought up, and the last time I recollect its being discussed was in 1913, when the subject was discussed on both sides of the House, and when the late Right Hon. Sir Wilfrid Laurier entirely concurred in the view that these papers were not of a kind that ought to be ordered to be brought down.

Mr. SPEAKER: Shall the motion stand, or is it dropped?

Mr. CASGRAIN: Dropped.

Motion dropped.

BOARD OF COMMERCE.

Mr. P. F. CASGRAIN (Charlevoix-Montmorency): I desire permission to revert to Order No. 5:

For a copy of all investigations, reports and proceedings in connection with the work carried on by the Board of Commerce, along with a copy of all decisions rendered showing sentences or fines imposed by the said board and a statement showing the costs of conducting such proceedings and investigations.

CHAMPLAIN MARKET SITE.
