FEDERAL CONTRIBUTIONS TO ANTI-ALCOHOLISM OR  
TEMPERANCE, 1970

Question No. 1,068—**Mr. Mather:**

What, in dollars, was the amount of federal contributions to anti-alcoholism or temperance in 1970?

**Hon. John C. Munro (Minister of National Health and Welfare):** Under the Public Health Research Grant an amount of \$37,306 has been approved for the fiscal year 1970-71, to assist the provinces in carrying out research activities in the field of alcoholism. In addition, a sustaining grant of \$15,000 was provided directly to the Canadian Foundation on Alcoholism.

Furthermore, during 1969-70, the following Welfare Grants were made for Alcohol Education: Yukon Territory, \$6,656; North West Territories, \$56,616.

A number of welfare institutions and welfare agencies supported under the Canada Assistance Plan are also involved in programs which treat alcoholism. However, expenditure for this particular purpose cannot be segregated or identified.

TO CIA AID TO SOUTH VIETNAM

Question No. 1,123—**Mrs. MacInnis:**

1. Did the government investigate a claim in 1969 that a Canadian member of ICC had handed information to CIA?
2. Was an investigation instituted and, if so, with what results?
3. Does the government intend to further investigate the matter?
4. Since August 15, 1968, has the federal government contributed aid, in any form, to the government of South Vietnam, and, if so, what was the total amount of such aid?
5. Are there Canadian-funded hospitals in Quang Ngai and Qui Nhon serving the Vietnamese civilian community and, if so, to what extent?

**Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council):** 1. No.

2. and 3. Not applicable. 4. Normal accounting procedures are to calculate expenditures on a calendar-month basis. Using those figures, Canadian aid to South Vietnam from 1st August 1968 to the present, totals some \$5,700,000.

5. There are two clinics in Vietnam which are meeting the needs of the civilian population. At Quang Ngai, there is a two-storey T.B. Clinic which was built and equipped by Canada. The construction was completed in December 1967. The Clinic functions primarily as an out-patient, ambulatory service of the province public health program for the detection, control and prevention of tuberculosis. A five-year plan calls for the gradual phasing out of Canadian support for the project. A Rehabilitation Centre at Qui Nhon, which was built and

equipped by Canada, has been open since mid-1969. As at Quang Ngai, emphasis is on out-patient treatment. Under the terms of a five-year plan, there are up to eleven Canadian advisers to the Vietnamese staff with a gradual phasing out of Canadian participation.

1. How many individuals have been employed by CMHC in the past two years at a salary of \$15,000 a year or more and, what are (a) their names (b) their responsibilities (c) their present salaries?

2. How many of the individuals in Part 1 are members of the staff of the Minister without Portfolio responsible for Housing and, in each instance (a) what are their specific responsibilities (b) what are their qualifications?

3. Is Douglas Bailey an employee of CMHC or the Minister's staff and, if so, what is (a) his position (b) his salary (c) his qualifications?

**Hon. Robert K. Andras (Minister without Portfolio):**

1. Central Mortgage and Housing Corporation has taken on strength 22 employees during the past two years at a salary of \$15,000 a year or more. (a) (b) (c) The names, salaries and duties of employees of CMHC are internal administrative matters. It has not been the practice, nor is it considered appropriate, to answer questions relating to the internal administration of the Corporation.

2. None of the 22 individuals in Part 1 are members of the staff of the Minister without Portfolio responsible for Housing. (a) (b) (c) Not applicable.

3. Douglas Bailey is not an employee of Central Mortgage and Housing Corporation or the Minister's staff. (a) (b) (c) Not applicable.

**Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce):** The Dominion Bureau of Statistics reports that: 1. Domestic disappearance (consumption, spoilage, etc.) of eggs for the years 1968, 1969 and 1970 was as follows:

1968	442,734 (excludes Newfoundland)
1969	456,964
1970	464,925

\*Excludes eggs for hatching.

2. The data are not available to answer this question mainly because figures on interprovincial movements are not complete.
