REQUIREMENT THAT WAR VETERANS ALLOWANCE RECIPIENTS APPLY FOR GUARANTEED INCOME SUPPLEMENT

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, my question is directed to the Minister of Veterans Affairs. In view of the anxiety expressed by many veterans 65 years of age or over who are receiving war veterans allowances because of a notice to the effect that they must apply for a guaranteed income supplement or be regarded as doing so, will the minister make a statement as to why this is being done and the authority for it?

Hon. Jean-Eudes Dubé (Minister of Veterans Affairs): Mr. Speaker, it is quite clear that there will be increases of 10 per cent in disability pensions and 15 per cent in war veterans allowances. Recipients of war veterans allowances have been asked to go and receive their OAS and GIS first so that additional resources will be made available to them. This is quite satisfactory and there is no question concerning it. These people are aware of the situation.

Mr. Knowles (Winnipeg North Centre): Will the minister check into the aspect of the notice which tells these veterans that they must so apply and that if they do not do so they will be regarded as having done so? That is the point on which we would like to have an explanation.
