SPECIAL STUDY OF NATIONAL CAPITAL

Question No. 2.474-Mr. Clark (Rocky Mountain):

- 1. What are (a) the terms of reference (b) the operating budget (c) the personnel (d) the expected date of report of the Special Study of the National Capital?
- 2. Was it the decision of the Minister that the Study would not involve public hearings and, if not, by whom was it taken?

Right Hon. P. E. Trudeau (Prime Minister): 1. (a) "To undertake a study of the most effective arrangements for the future administration of matters directly affecting the National Capital and its development, including the role of the National Capital Commission and its relation to other bodies concerned with the governing of the Capital Region and the coordination of those federal activities which bear upon the development of the Region as a national capital". (b) For the fiscal year 1973-1974, \$130,-000. (c) At the present time, in addition to Mr. D. H. Fullerton, one administrator and one secretary. Several other additions to the staff are contemplated, together with the part time assistance of consultants. (d) Within one year from June 1, 1973.

2. The decision on public hearings rests with Mr. Fullerton, although the Study has not been constituted under the Inquiries Act, and he therefore does not have the power to summon witnesses. No final decision on hearings has yet been taken, although Mr. Fullerton has said in his advertisement seeking submissions that "It is not my present intention to hold public hearings, since these would more appropriately flow from the review of the National Capital by a Special Committee of Parliament, the establishment of which the government is considering recommending at the next Session." He has added in correspondence on this question that the time, staff, and cost involved in public hearings would make it difficult to finish the study within the time and budget allotted to it, but that the matter would be reviewed in the autumn.
