RAILWAY EMPLOYEES—INQUIRY AS TO APPOINTMENT OF COMMISSIONER TO CONDUCT INQUIRY

Mr. Dan McKenzie (Winnipeg South Centre): Mr. Speaker, my question is directed to the Minister of Labour. In light of the fact that on March 11 he stated in the House that he would be making significant moves in the direction of appointing a commissioner to go into all aspects of railway pensions, may I ask the minister what is the current status of his position on this matter?

Hon. John C. Munro (Minister of Labour): The matter is under active consideration, Mr. Speaker.

Mr. McKenzie: Having regard to the grave and serious concern expressed by all parties in the House, will the minister immediately introduce a government bill to amend the Pension Benefits Standards Act to remove the CNR from the scope of that act in order that, without adding substantially to its annual deficit, it may improve its pension plan, noting that private member's Bill C-139, introduced by the—

Mr. Speaker: Order, please. Perhaps the minister might be allowed to reply to the hon. member's question, without the hon. member's additional notice.

Mr. Munro (Hamilton East): As I understand it, Mr. Speaker, the hon. member is referring to a private member's bill introduced by a member of this party, the hon. member for St. Boniface, who has been championing the cause of the railway workers for many years.

Some hon. Members: Hear, hear!

Some hon. Members: Oh. oh!

Mr. Munro (Hamilton East): The concept that is embraced in that private member's bill is under very active consideration with respect to measures the government can take to rectify the situation dealing with the pensions of railway workers. I have this matter under discussion with my colleague, the Minister of Transport. We hope to come up with a solution very shortly.

Mr. McKenzie: Would the minister not agree that a government bill would carry far more weight than a private member's bill, and would be—

Drury (President of the Treasury Board): Mr. Speaker, the use of private placement agencies is something done not by the Treasury Board but by departments to fulfil urgent, unforeseen needs. As long as there are no abuses from the taxpayers' and the government's point of view, the practice probably will continue.

Mr. Blackburn: Mr. Speaker, as a supplementary question I would like to ask the Minister of Manpower and Immigration if his department is considering taking over this operation?

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, I believe I replied to the same question a few days ago by saying that while we are looking at it we are not now authorized to operate an overload system. We will explore and are in fact exploring this question with other departments of government.
