## NUCLEAR POWER AS ALTERNATIVE SOURCE OF ENERGY

#### Question No. 2,719—Mr. Forrestall:

Is nuclear power competitive with fossil fuels when the latter exceed \$4 per barrel and, if so (a) are the Pulp and Paper industries as well as the Marine industries paying upwards of that amount (b) what specific steps is the government now taking to explore the advantages of nuclear power as an alternative source of energy?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): The Department of Energy, Mines and Resources reports as follows: Nuclear energy is competitive as a source of electrical power with crude oil exceeding \$4 per barrel. This economic advantage occurs only for large units and therefore nuclear energy is not competitive as a source of power for industrial or marine uses. Atomic Energy of Canada Limited and the Department of Energy, Mines and Resources carry out continual surveys to monitor the changing economic situation.
