Indian Affairs and Northern Development. Has he agreed to meet with the residents of the St. Lawrence islands parks region to discuss their many objections to the government's park expansion plan and when and can he guarantee there will be no expropriation of private property.

Hon. Judd Buchanan (Minister of Indian Affairs and Northern Development): Mr. Speaker, I am looking at the book. Sometime next week, I believe on Thursday or Friday, I will be meeting representatives of the region. The question of expropriation presumably will be discussed. I have already said we hope there will be no expropriation, but if there is it will be in very limited key areas. We hope we will be able to get whatever properties are required on a voluntary basis. To date, some 20 people have come forward and offered their properties.

Mr. Cossitt: Mr. Speaker, can the minister advise the House the reason an official of Parks Canada, Mr. Christakus stated publicly to the residents in the area at a public meeting that the minister had conferred with his provincial counterpart before this expansion plan was announced because subsequently at least two provincial cabinet ministers have denied that any such meetings took place. Could the minister tell us if, indeed, he did confer with his provincial counterpart.

Mr. Buchanan: Mr. Speaker, I will have to check back. I do not think I did, but I believe there were discussions at the official level concerning the park.
