SUGGESTED RESCINDING OF GUIDELINES ON HOUSING AND EDUCATION PENDING CONSULTATIONS WITH NATIVE REPRESENTATIVES—MOTION UNDER S.O. 43

Mr. Ray Hnatyshyn (Saskatoon-Biggar): Mr. Speaker, I rise pursuant to Standing Order 43 on a matter of urgent and pressing necessity. In view of the fact that the Department of Indian Affairs and Northern Development has recently implemented policy guideline circulars effective April 1, 1975 affecting Indian rights and obligations, in view of the fact that there is evidence that these circulars have been rejected by all elected Indian leaders, and since funding from the department will be cut off to bands not abiding by the guidelines causing substantial apprehension and concern amongst our native peoples, as well as in view of the minister's statement in the House of Commons on May 6, 1975 that if the guidelines create difficulties and problems his department is prepared to change them, I move, seconded by the hon. member for Lambton-Kent (Mr. Holmes):

That the Minister of Indian Affairs and Northern Development immediately rescind the policy guideline circulars respecting housing and education and immediately convene meetings with elected chiefs and their representative bodies to obtain a consensu on mutually satisfactory guidelines to replace the present unsatisfactory guidelines.
