AMENDMENT RESTRICTING RIGHT OF JUDGES WITH RESPECT TO JURY ACQUITTAL VERDICTS

Right Hon. J. G. Diefenbaker (Prince Albert) moved for leave to introduce Bill C-395, to amend the Criminal Code (appeals).

An hon. Member: Explain.

Mr. Diefenbaker: Mr. Speaker, may I explain the reason for the proposed amendment? It arises because of the unprecedented judgment of the Supreme Court of Canada in the Morgentaler case, unprecedented in 300 years of British experience with juries and in the entire history of our country. Because of the judgment, judges are now in a position to substitute their judgment for the verdict of a jury. In the opinion of members of the legal profession in all parts of Canada and members of the civil rights organization, unless this amendment is accepted the jury system will be emasculated, if not destroyed. Indeed, justice will be denied.

Motion agreed to, bill read the first time and ordered to be printed.
