**FUNDS FOR URBAN TRANSIT SYSTEMS—REQUEST FOR
RECONSIDERATION OF FUNDING OF SOUTH WEST TRANSIT
STUDY FOR WINNIPEG**

Mr. Dean Whiteway (Selkirk): Mr. Speaker, my question is to the Minister of Finance. It has to do with the Toronto rebellion. In view of the uprising in his own caucus after his decision last week to renege on a campaign promise to supply funds for urban transit systems, is the minister now prepared to reconsider that decision and include it in the upcoming budget? It is a policy which Canadians considered to be serious rather than a hollow campaign promise.

Hon. Donald S. Macdonald (Minister of Finance): As I pointed out last week, Mr. Speaker, we have given an undertaking, indicated most recently by my colleague, the President of the Treasury Board, with regard to restraint on federal expenditures and we intend to hold to that.

Mr. Whiteway: My supplementary question has to do with a study commissioned by and paid for in large part by the minister's department with the province of Manitoba and the city of Winnipeg a year ago. The minister will recognize it. It is called "South West Transit Study". In his announcement last week, the minister effectively killed that project, a project on which he asked for a tri-level study. Is the minister at least prepared to consider that one transit study and fund it rather than cut it off at the knees?
