Since April 1, 1975, what amount was spent on studies related to marijuana by the Department of National Defence?

HAZARDOUS PRODUCTS

Question No. 846—**Mr. Howie:**

Since January 1, 1978, did the Department of Consumer and Corporate Affairs ban or recommend against the use of (a) children's toys (b) consumer appliances?

Miss Aideen Nicholson (Parliamentary Secretary to Minister of Consumer and Corporate Affairs and Postmaster General): (a) Yes. Actions during 1978 included removal from the market of four styles of plush toys containing excessive amounts of lead in paints used for decorative lettering. For the 1979-80 fiscal year, enforcement activity with respect to toys was as follows: inspections—1,479; products examined—8,332; recall actions—65 (involving 90,150 product units); removal/disposal actions—248 (involving 101,790 product units).

(b) No. Household appliances, both electrically-operated and gas-fueled, are subject to provincial laws requiring compliance with safety standards of the Canadian Standards Association and the Canadian Gas Association. To avoid duplication of effort, the department has not intervened in this provincially-regulated area of product safety. The department does, however, maintain close contact with the responsible provincial authorities and provides some input to the safety standards development process.

CANADA-EEC CHEESE ARRANGEMENTS

Question No. 879—**Mr. Cossitt:**

Is the government bound by the present total of approximately 45 million pounds of mostly specialty cheeses imported into Canada as a result of GATT negotiations and, if so, will it take steps to reduce this quota as soon as negotiations can be carried out in order to assist Canadian dairy farmers?

Hon. Herb Gray (Minister of Industry, Trade and Commerce): In so far as the Department of Industry, Trade and Commerce is concerned: the actual level of the global cheese quota was set at 45 million pounds as part of the over-all dairy program for the current dairy year and thus independently of
