

Order Paper Questions

Basically we get back to the ruling which Madam Speaker made on February 16, as reported on page 15053 of *Hansard*. In dealing with the point of order raised at that time as to whether or not it was appropriate for the borrowing authority to be combined with Ways and Means motions relating to excise tax, Madam Speaker said:

As I indicated to the House on January 19, 1981, I have no quarrel with the practice of combining in the same bill taxation matters based on Ways and Means motions with the borrowing authority, provided the notice provision was respected.

I submit that the same principle applies here. We have a Ways and Means motion which is related to the bill. There are other matters in it, but there is a common denominator or thread throughout it. We are implementing one package, namely, aspects of the national energy policy which were not included in Bill C-48. I submit that the bill is perfectly in order.

Madam Speaker: I thank the hon. member for Calgary Centre (Mr. Andre) for raising the point of order and other hon. members who have contributed to elucidating it. I will take the matter under advisement and rule on it later.

Question No. 2,769—**Mr. Cossitt:**

What is the annual salary of Mr. Donald Marriott, Director of Restaurants and Catering of the National Arts Centre, and what is a complete history of his education and employment experience that was a consideration in his hiring, including all the businesses where he worked and the type of work he performed?

Mr. Jack Masters (Parliamentary Secretary to Minister of Communications): I am informed by the National Arts Centre as follows: The position Mr. Marriott occupies is classified at a salary range of \$39,100—\$52,700. The additional background information is of a personal nature concerning Mr. Marriott, the disclosure of which is governed by the Canadian Human Rights Act, Part IV.

1. What is a complete record of employment in the Public Service of Mrs. Bonnie G. Trotman?

2. Is Mrs. Trotman presently employed by the Department of Employment and Immigration Centre at Prescott, Ontario in the constituency of Leeds-Grenville and, if so, what are her duties?

Hon. Lloyd Axworthy (Minister of Employment and Immigration): 1. In so far as the Canada Employment and Immigration Commission department records indicate, the reply is:

November 26, 1969--Appointed on a term basis at the ST 3 level, Canada Immigration Centre, Prescott

June 6, 1970--Tenure of employment changed from term to indeterminate status

January 1, 1971--Position and incumbent reclassified to the ST 4 level

September 24, 1973--Position and incumbent converted to the ST-SEC 1 level

November 3, 1975--Promoted to the CR 3 level

Mrs. Trotman received acting pay at the PM 1 level as a Border Examination Officer, Prescott, for the period October 3 to 30, 1977.

2. Yes. Mrs. Trotman is presently employed as a CR 3, secretary/clerk receptionist at the Canada Immigration Centre, Prescott.

Her duties are: to provide secretarial and general clerical services; to perform financial functions; to receive and counsel clients, referring in-depth cases to the immigration counsellor; to receive immigrant and non-immigrant applications; to action case files.
