Madam Speaker, as far as the business of the House for next week is concerned, on Monday we shall resume debate on the second reading stage of Bill C-139, to amend the Income Tax Act, and since we have already spent ten hours on this debate, we hope to be able to complete second reading as soon as possible, so that the House can sit in Committee of the Whole to consider the details of this legislation, which arises from several previous budgets and ministerial statements on the financial situation.

The Minister of Finance (Mr. Lalonde) also intends to give notice of a Bill to authorize the Government to borrow additional funds until the end of the financial year and the beginning of the next one. This legislation is expected to be introduced next Monday, and if it is, I would like to inform the House that Tuesday morning at eleven o'clock we shall proceed with debate on second reading of this very urgent borrowing authority Bill.

Wednesday will be private members' day, as usual, and Thursday, if necessary, we shall continue debate on second reading of the borrowing authority Bill. I shall be giving notice in due time if there is to be an Opposition day next week, possibly on Friday, but that has not been decided yet.
