Ordered, That the said Resolution be communicated, by Message, to the Legislative Council.

Ordered, That the Hon. the Colonial Secretary do carry the said Message to the Council.

Resolved, That a Committee of five Members be appointed to examine Bills to be engrossed or that have been engrossed.

Ordered, That Mr. Clark, Mr. Macdonald, Mr. Munro, Mr. Perry and Mr. H. Haviland, do compose the said Committee.

Resolved, That a Committee of five Members be appointed to revise the Journal of each day, after the adjournment.

Ordered, That Mr. Muirhead, Mr. Perry, Hon. Mr. Montgomery, Hon. Mr. Longworth and the Hon. Mr. Palmer, do compose the said Committee.

Resolved, That a Committee of seven Members be appointed to examine and report on the Public Accounts, with power to send for persons, papers and records.

Ordered, That Mr. Macdonald, Mr. Perry, Mr. Muirhead, Hon. Mr. Wightman, Mr. Munro, Mr. Dingwell and Mr. Cooper, do compose the said Committee.

Resolved, That a Committee of three Members be appointed, to whom shall be referred every Private Bill, to report thereon to the House.

Ordered, That Mr. Clark, Mr. Laird and the Hon. Mr. Whelan, do compose the said Committee.

Ordered, That the postage on all letters and printed papers to and from Members of this House, during the Session, be charged to the contingent accounts of the House.

Ordered, That a copy of the Journal of this House be sent to His Excellency the Lieutenant Governor, each day, as soon as may be, after the adjournment.

Then the House adjourned until to-morrow at ten o'clock.

RESOLVED, That no Petition praying aid for Roads, Bridges or Wharfs, or for any object of a local or private nature, be received after Tuesday, the 17th day of March next.

Ordered, That the said Resolution be inserted in all the Newspapers published in Charlotte-town.

Mr. Clark, from the Committee appointed to receive Tenders for the Printing of the Journal of the House, and to report thereon, presented to the House the report of the said Committee, which report being again read at the Clerk's Table, was agreed to by the House, and is as followeth :—

The Committee appointed to receive Tenders for printing the Journal of the House of Assembly, during the present Session, have to report that they have received three Tenders :

First :—From Mr. John Walsh, offering to perform the work at the rate of thirty-three shillings and six-pence per

sheet of four pages; binding, four shillings per copy; stitching, one shilling and sixpence each copy.

Second :—From Mr. John Ings, offering to perform the said work at the rate of thirty-four shillings and five-pence per sheet of four pages; binding each volume, four shillings; stitching each volume, one shilling and five-pence.

Third :—From Mr. Thomas Burris, as follows :—For each sheet of four pages, the sum of thirty seven shillings and six-pence; binding each volume, four shillings and three-pence; stitching each copy, one shilling and six-pence. Your Committee recommend that the Tender of Mr. John Walsh be approved of, it being the lowest.

Ordered, That the like number of copies of the Journal as was ordered to be printed last Session, be printed and distributed, this Session.
