the vestibule. There was a smell of gunpow-
der. Mr. Westwood followed her to the phone

mony of Detective Henry Reburn, to whom
the prisoner confessed that Clara Ford
was brought into the office on November
11. He asked her the name of the man
who was brought there. She replied, "For
the murder of Frank Westwood."

He questioned her that anything she might
be used against her, to which she
replied that she did not care, that she
was innocent and could prove it. He
asked her who was with her and she
replied Florence McKay.

After lunch on Saturday Reburn con-
fessed his evidence and the full confession
was put in. He said he had been in
Parkdale to see Clara Ford, whom he
intended to plead guilty in the police
court.

Her confession was made after Florence
McKay told Clara that she were not at
the theatre together on the Saturday.
She stated her intention of going to
the theatre, and that she had been in
Parkdale on the Saturday night, but she
had given her the Ford on two
days after the shooting.

After the witness had warned Clara she
told him that she shot Frank Westwood
because at the latter end of July he had
been in the habit of taking liberties with
her. She told him that she would give
evidence against him. He asked her who
was with her and she replied Florence
McKay.

Continuing her narrative, Clara Ford
said that she had been in Parkdale to
