The principle of manual training in making sure through somewhat slow progress in our schools. It is now called by our foremost educators that some form of technical training is necessary if the rising generation of Nova Scotia is to hold its own in the industrial world.

We append herewith a communication from a Boston fruit exporter dealing with the much mooted question of improved packages in which to transport and market apples.

From the evidence of English commission merchants and of Canadian and American shippers, as well as that of independent observers there can be no doubt that a change such as our correspondent suggests would mean a very decided advantage to our apple growers.

All my foreign correspondents agree that the apple crop of Europe is a failure this year, and that there will be an immense demand for American apples in consequence.

This box is somewhat similar to the orange case. It can be made of any kind of wood. The ends and middle pieces of the box should be made of 2 inch wood, to be 124 inches long and wide.
