2 and 3. Value of imports of spraying and dusting machines entered for consumption in the province of Nova Scotia, and duty collected January 1 to April 30, 1931: Value, \$14,361; Duty, \$3,590.25.

\*4 and 5. Value of all agricultural implements and machinery entered for consumption in the province of Nova Scotia, and duty collected, January 1 to April 30, 1931: Value, \$24,918; Duty, \$5,338.95.

3. What was the lowest wholesale price per pound at which farm butter sold in Canada during the month of May, 1930, and May, 1931 1931?

Mr. STEVENS:

1, 2 and 3. In recent years the amount of farm butter marketed has been decreasing steadily. At the present time it is not being marketed regularly in wholesale quantities, although retailers undoubtedly handle considerable amounts received direct in small lots. For this reason it is not possible to give definite prices as requested.
