AFTON-BAYFIELD-SUMMERSIDE RURAL MAIL SERVICE

Mr. BLACK (Cumberland):

1. Did the Postmaster General or the Post Office Department receive a petition from eligible residents along the proposed rural mail route at Afton-Bayfield-Summerside in Antigonish county, Nova Scotia, objecting to the establishment of such route?

2. If so, how many persons signed such petition?

3. Do they represent fifty per cent or more of the eligible residents?

4. Is a rural mail service being established? If so, when will it start operating?

5. Who is the courier and what remuneration is he paid?

Mr. BERTRAND (Laurier):

1. Yes.

2. Petition has 76 signatures.

3. Not known.

4. It is proposed to establish rural mail delivery service when 50 per cent of eligible residents have purchased and erected boxes.

5. Proposed contractor is John James Jones, at \$1,100 per year.

FERRY STEAMER "PRINCESS HELENE"

Mr. BERTRAND (Laurier): A few days ago another question was asked by the hon. member for Cumberland (Mr. Black) concerning the steamer Princess Helene. I did not have the answers ready and therefore asked that the question be made an order for return. I find that the answer is ready and I therefore ask that I be permitted at this time to file the answer to that question.

Mr. BLACK (Cumberland):

1. Has the ferry steamer *Princess Helene* been taken off bay of Fundy service, Digby-Saint John, for a period from April 26 to May 18 this year

2. Is there a contract for conveying the western mail to and from Digby, Yarmouth and such points via this route?

3. What provision has there been for con-veying the mail when the *Princess Helene* is off duty during this period? Has it resulted in delays

4. What is the contract price per year for conveying such mail and for subsidy for operating the steamer?

Mr. BERTRAND (Laurier):

1. Yes, for annual overhaul.

2. Yes. Contract with Canadian Pacific Railway under order in council P.C. 1473 of 6th March, 1945.

3. During suspension of ferry service mails usually conveyed by the steamer have been routed by railway. This results in delay in some instances.

4. Contract price is 50 cents per mile. Actual payment made during fiscal year ending 31st March, 1948, was \$13,500.

No subsidy is paid.
