bill would include some of the provisions which have been placed in the laws of other commonwealth countries in recent years in order to accomplish this purpose.

Motion agreed to and bill read the first time.

CRIMINAL CODE

AMENDMENT TO ABOLISH IMPOSITION OF CORPORAL PUNISHMENT

Mr. Frank McGee (York-Scarborough) moved for leave to introduce Bill No. C-10, to amend the Criminal Code (corporal punishment).

Some hon. Members: Explain.

Mr. McGee: Mr. Speaker, the explanation for this bill was placed on the record when it was introduced in 1957.

Motion agreed to and bill read the first time.

AMENDMENT TO ABOLISH CAPITAL PUNISHMENT EXCEPT FOR TREASON

Mr. Frank McGee (York-Scarborough) moved for leave to introduce Bill No. C-21, to amend the Criminal Code (capital punishment).

Motion agreed to and bill read the first time.

AMENDMENT WITH RESPECT TO WATER POLLUTION

Mr. H. W. Herridge (Kootenay West) moved for leave to introduce Bill No. C-32, to amend the Criminal Code (nuisance).

Some hon. Members: Explain.

Mr. Herridge: Mr. Speaker, this is a very important bill, and at the insistence of hon. members around me I should like to explain it. In explaining the purpose of this bill, Mr. Speaker, I cannot do better than repeat the illuminating and inspiring words used by the Prime Minister when he introduced an identical bill in this house on February 28, 1955. I use the Prime Minister's words with relish.

Mr. Speaker, as provincial legislation has proven ineffective to control the wanton pollution by municipalities and industrial concerns of interprovincial rivers, the purpose of this bill is to amend the Criminal Code to provide punishment for the offence of water pollution.

This amendment is demanded by tens of thousands of people, literally hundreds of thousands in this country, who are asking for some action on the part of the federal government to protect them from the cupidity of those who, because of their power, believe they can with impunity deny the use of these waters to present and future generations.

I am glad to note the indication in the throne speech, Mr. Speaker, that the government has given serious consideration to this problem.

Motion agreed to and bill read the first time.

INDUSTRIAL RELATIONS

PROVISION OF STATUTORY HOLIDAYS WITH
PAY FOR EMPLOYEES
