We discussed Pepperrell air base and various other matters that have concerned our two governments for some time. I am not in a position yet to reveal the decisions made because they require ratification on the part of both governments, but I am sure when the announcement is made it will be widely accepted and applauded as an example of that co-operation which should prevail between the federal government and the provinces.

Hon. L. B. Pearson (Leader of the Opposition): Mr. Speaker, on the subject of co-operation would the Prime Minister care to comment on the reported statement of his colleague, the Associate Minister of National Defence, to the effect that the yellow peril is one of the most terrible threats to western civilization?
