Gordon (Minister of Finance): Mr. Speaker, the government is considering urgently and almost daily certain proposed amendments to be presented in connection with the National Housing Act. I would not want my hon. friend to think that my answer of the other day encompassed any immediate change or any prospective change in the rate of interest on National Housing Act loans. This is a matter, however, that the government has under consideration all the time.

MacEachen (Minister of Labour): Mr. Speaker, last summer a special vote was provided in the estimates of the Department of Finance to provide for accelerated winter projects not otherwise provided for in the main estimates. These accelerated projects had application to areas designated by the Department of Industry and the Department of Labour as areas of high winter unemployment. I would have to make further inquiries with respect to the post office aspect of that general program.
