The investigation and the prosecution of offences of a criminal nature that have taken place prior to a bankruptcy are a provincial responsibility within the field of the administration of criminal justice. There are no federal statistics available as to the number of investigations or prosecutions initiated by the provincial authorities and connected with estates in bankruptcy or as to how these estates could have been affected by the offences that might have been uncovered by the provincial authorities.
