GRAIN

CANADIAN BOX CARS ON U.S. RAILWAYS

Mr. John L. Skoberg (Moose Jaw): Mr. Speaker, I should like to direct my question to the Minister of Transport. In view of the great demand for grain cars in western Canada for the movement of grain, and in view of the fact that the president of the Canadian Transport Commission on November 28 said that the transport committee will be looking into the number of Canadian box cars on United States lines, could the minister say whether there is any unduly large numbers of Canadian cars on U.S. railroads?

Hon. Paul Hellyer (Minister of Transport): There are a considerable number, Mr. Speaker. I think this will be reflected in an answer to a written question which will be tabled next week. In addition to this I might add that most of the box cars in the United States are not those that would be suitable for the movement of grain. It is necessary to have both sets of figures, and I hope that both sets can be produced.

Mr. Skoberg: May I ask the minister an additional question. Has he made the Canadian Transport Commission aware of the situation, and is he instructing them to look into the situation at all times?

Mr. Hellyer: Yes, Mr. Speaker, they are very much aware. The Minister of Industry, Trade and Commerce is also in constant communication with them and we have undertaken, in effect, to do anything that it is felt is required to assist in the movement of grain.
