INCOME TAX

SUGGESTED ELIMINATION OF FAST WRITE-OFF PROVISIONS AND REDUCTION IN CORPORATE RATE— GOVERNMENT POSITION

In view of evidence that corporate profits in 1973 are going up at a faster rate than the cost of living, the consumer price index for food, wages and what have you, is the minister in his next budget planning to eliminate the fast write-off provisions and bring the corporate tax rate back to the level at which it stood a year ago?

Hon. John N. Turner (Minister of Finance): Mr. Speaker, that, of course, is a budgetary matter. I ought to indicate to the hon. member that as a result of the corporate tax reductions and the healthy profit picture, the capital intentions for business equipment and plant were raised by 19 per cent this year over last.

Some hon. Members: Hear, hear!

NEED FOR ACTION TO PREVENT EXCESSIVE PROFITS

Mr. Terry Grier (Toronto Lakeshore): I have a supplementary question arising from the Minister's answer and assurances which the Prime Minister gave to the House on more than one occasion to the effect the government would contemplate whatever steps were required to protect the consumer from being gouged in the market place. In view of that statement and assurance, and in view of the evidence of rising corporate prices, can the minister indicate what concrete steps are being planned to prevent excessive profits being made?
