POSSIBILITY DREDGING WORK BEING DONE BY UNITED STATES OR PUBLICLY OWNED COMPANIES—NUMBER OF JOBS LOST

**Mr. Max Saltsman (Waterloo-Cambridge):** Mr. Speaker, I should like to direct my question to the Minister of Public Works and ask him, in view of the statement last night by the minister that he is considering inviting bids from U.S. dredging companies as well as considering some form of public ownership, whether he can tell the House how far he has gone in his negotiations with U.S. firms and to what extent has the department examined the public ownership options?

**Hon. C. M. Drury (Minister of Public Works):** Mr. Speaker, there have been no negotiations with any U.S. firms, and the advisability of the public ownership of certain operations, the pros and cons, is under continual review, not only in the dredging field but also in many others.

#### HOUSING

INABILITY OF MOBILE HOME OWNERS TO OBTAIN \$500 GRANT BECAUSE OF LEASE PERIOD—GOVERNMENT POSITION

**Mr. C.-A. Gauthier (Roberval):** Mr. Speaker, I should like to put a question to the Minister of State for Urban Affairs. My question deals with the new \$500 grant to purchasers of new homes.

Is the minister aware that 90 per cent of buyers of mobile homes cannot obtain the grant because they do not have five-year leases on their lots? If so, does he intend to take the necessary steps to make new owners eligible for that grant?

**Hon. Barney Danson (Minister of State for Urban Affairs):** Mr. Speaker, I am aware of the situation with reference to mobile home owners. The basic reason we have set a five year land lease is to make certain that it is a permanent residence. I want to look at the nature of those land leases and also those people who move on a fairly regular basis due to the mobility of their jobs. This came up before the parliamentary committee, and the president of CMHC and I will be looking into this.
