THE BUDGET

PROVISIONS GOVERNING INCOME TAXES—MOTION UNDER S.O. 43

Hon. Ron Huntington (Capilano): Madam Speaker, I rise on a matter of urgent and pressing necessity. Whereas jobs and payrolls depend on a stable economic environment, and whereas a stable taxation environment is essential to the work force of the nation, and whereas resolutions No. 9, accrued investment income, No. 23, restricted interest expense, and No. 31, capital gains and other reserves, in the November 12 budget attack the fundamental principle of a fair taxation policy, namely, the ability to pay, and whereas these stated resolutions impose the unfair principle of retroactivity on taxpayers in Canada thus doing irreparable damage to a fair and reasonable taxation environment, I move, seconded by the hon. member for Central Nova (Mr. MacKay):

That the Minister of Finance withdraw resolutions Nos. 9, 23 and 31 of the November 12 budget in order to avoid a major economic calamity that will affect every single Canadian.

PROVISIONS AFFECTING SMALL BUSINESS—MOTION UNDER S.O. 43

Mr. Stan Darling (Parry Sound-Muskoka): Madam Speaker, the November 12 budget presented by the government has deeply angered small business men and business women across the country. As the details of the budget are more closely examined, there is a growing fury as these Canadians realize that many of the measures outlined by the Minister of Finance (Mr. MacEachen) will, in the long run, result in even further financial pressure.

In light of the fact that the budget, while offering minimal relief only to those in extreme financial straits, is a pronounced step backward for the remainder of the business community and has been described, in the words of John Bulloch, president of the 62,000-member Canadian Federation of Independ-

ent Business, as a "bag of snakes", I move, seconded by the hon. member for Prince Edward-Hastings (Mr. Ellis):

That the Minister of Finance admit to the retrogressive and punitive measures directed at small business and either withdraw his budget or take immediate action to change its terms of reference.
