BRAZILIAN STRONGER ON TORONTO MARKET

Trading in Domestic Issues Some-what Tame and Most Issues Are Only Steady.

The steadiness of the local market was broken yesterday by another advance in Brazilian. Like most market operations the movement was extremely sudden and only accounted for by buying orders which carried the price up two points before floor traders had much chance to operate. The advance in Brazilian aided the market generally and Cement and Steel Corporation shares maintained a strong advance, selling up to 5 1/2. Subsequent buying of this stock is going on at Montreal and the market here following. Dealings otherwise than in the issues mentioned were quite thin and transfers were made at unchanged prices. The unlisted department showed a little more spirit with fairly large transactions in some of the mining stocks. Brokers are not anticipating much change in the market as a whole until the pending war loan has been disposed of.
