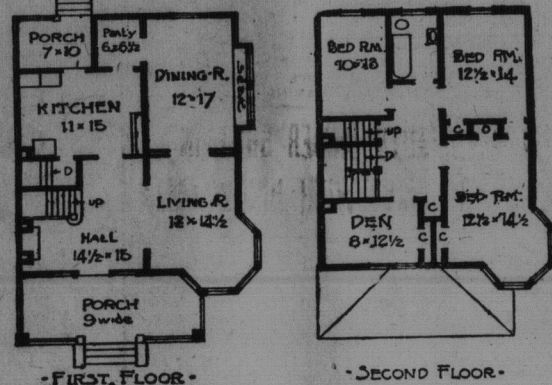

FIFTEEN CASES ON THE DOCKET

A busy session for Divorce Court next month—Nine of the cases, new ones.

Frederickton, June 13.—In the court of Divorce and Matrimonial Causes in New Brunswick, which will open on July 7th, there are no less than fifteen cases on the docket, the largest on record.

Three of the cases have already been tried and the decisions by Justice McKinnon are only required to wind them up, while two other cases have been partly finished and will not take long to complete.

The other nine cases are entirely new, being as follows: Sarah Frances Ross vs. Robert Ross; Richard Burrows vs. Annie Burrows; Milton Lemuel Perry vs. Flora Gwyneth Perry; Walter H. Appleby vs. Maggie Appleby; Clara Kent Douthright vs. Adam M. Douthright; Nancy Maud Bugless vs. Clement Darlington Bugless; Kathleen Frances Wheaton vs. James Bernard Wheaton; Herbert B. Parlee vs. Mary Parlee; John James Melanson vs. Mary Melanson.

The Ross and Burrows cases arise out of the criminal cases which were heard in the courts in St. John some time ago, in which Robert Ross and Annie Burrows were found guilty of certain charges.

In the Perry case the plaintiff is a street railway employee at St. John and formerly lived with his wife, who was a Miss Brown, at L'Etang, Charlotte Co. He names William Austin, of L'Etang, as co-respondent, with the usual statutory causes named for seeking an absolute divorce.

In the Appleby case the plaintiff is a farmer at Nauwigewauk, Kings Co., while the defendant was formerly Miss Maggie Snodgrass, of Young's Cove, Queens Co. He was 38 years old and she was 40 when they were married by Rev. Henry Pierce at St. John on Sept. 10th, 1913. They lived together until the following December and have since lived apart. No co-respondent is named, the grounds for action being unusual, and the first case of its kind since six years ago.

The plaintiff in the Bugless case was formerly Miss Nancy Maud Stiles, daughter of Henry A. Stiles, of Riverside, Albert Co. She married the defendant in 1910 and returned to her former home in Albert Co., where she was ill and under the doctor's care for a long time. She says the name of the co-respondent is unknown to her and charges that her husband drank liquor to excess and was habitually very violent and cruel in his action and conduct. The defendant now resides in Rochester, N. Y.

Kings County is providing the full share of cases for the coming session. Mrs. Douthright lives in Erb Settlement, not far from Sussex, and her husband formerly lived in Sussex, but now resides in Ontario where he is an agent. They were married at Watertown, Queens Co., March 19th, 1902, by Rev. H. H. Glinds, a goldsmith of this city, and they afterwards lived together at Berwick, Cole's Island, Penobscot and other places in Kings and Queens counties, lastly at Sussex until June 7th, 1911. Mrs. Douthright names Sadie C. Wiggins, wife of Eleazar Wiggins, as co-respondent, and further alleges that they are now living together. Mrs. Douthright was her own detective in the case and will be the principal witness. She has been residing at various places in Kings and Queens counties since parting with her husband and charges that during the last five years of their married life her husband "acted in a most brutal manner and several times threatened to strike her."

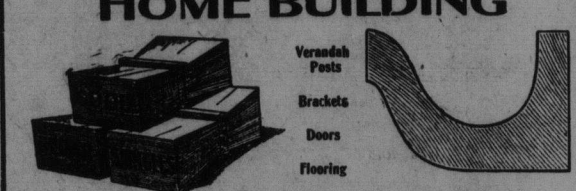

NEW YORK'S FIRST MAYOR.

The first mayor of New York, Thomas Willett, was inducted into office 240 years ago today, June 13, 1665, and it is expected that the American metropolis will formally observe the 250th anniversary of this interesting event a year hence. Gov. Richard Nicolls, the first English executive of the future Empire State, was responsible for the appointment of Willett, who was a wealthy merchant and trader and had a town house in New York and a country estate in Rhode Island, where his body was buried in 1674.

Willett, who was a shrewd business man, governed New York honestly and well, and after his first term of one year was made mayor again in 1667. The municipal government, of which he was the head, was composed of five aldermen, three Dutch and two English, and a sheriff, although police duties devolved largely upon the mayor, and he was police magistrate as well. He had his troubles with executive matters, and his conduct of police affairs was subjected to much criticism, a precedent being thus established which has been adhered to throughout the administrations of
