### **RECEIVES MEMORIAL MEDAL FROM KING**

Beautiful Memento Received by Clerk

Frank Whetter. A memorial medal of bronze from King George has been received by Frank H. Whetter, clerk of the Ninth Division Court, whose son, Richard Wetter, laid down his life in the great

war.
The young Londoner joined the Canadian forces early in the struggle and was reported missing after the terrific struggle at the second battle of Ypres.

The medal is of bronze, about five inches in diameter. It is done in relief and shows the British lion surmounted by a figure of peace with a laurel wreath outheld. The name of the young Canadian, also in relief, occupies a position to the right of the figure of peace. At the bottom on the extreme edge of the medal is a small figure of the British lion crushing an eagle, symbolic of the victory of British arms over Germany.

Accompanying the medal is a letter

from the King on Buckingham Palace stationery. It reads:

"I join with my grateful people in sending you this memorial of a brave life given for others in the great war. (Signed) "George R. I." This is the fifth decoration that Mr. Whetter has received. He has re-ceived three smaller medals and a cross within the past year.
