If, as he says, the effects of the oil price increase are inevitable, has the government made any assessment in order to be able to tell us when those effects will be felt? If so, how does the government intend to mitigate these effects, and will the one-price system for oil be maintained in this country?

Hon. Alastair Gillespie (Minister of Energy, Mines and Resources and Minister of State for Science and Technology): Mr. Speaker, the one-price system for oil is fundamental to the government's policy, just as the whole process of moving up to international prices in a graduated and manageable way is also fundamental to our policy.

The last time we moved to slow down price increases we were attacked by the opposition as if our action was some kind of an election ploy. It is about time the opposition stood up and told us and the Canadian people where it stands on this issue.

Hon. Allan J. MacEachen (Deputy Prime Minister and President of Privy Council): Mr. Speaker, I cannot tell the hon. member whether this particular subject matter was raised between the President of France and the Prime Minister, although I do know that their meeting was very constructive.

Mr. MacEachen: I add, by way of clarification, that the suggestion contained in the latter part of the hon. member's question would be entirely unacceptable to Canada and to my knowledge certainly has not been advanced by France.

CO-ORDINATOR TO ENSURE MAXIMUM USE OF RAIL CARS TO MOVE GRAIN

Mr. Jack Murta (Lisgar): Mr. Speaker, I would like to direct a question to the minister responsible for the Canadian Wheat Board.

Has the minister discussed with the relevant parties in the grain trade the possibility of the government's appointing a grain co-ordinator or somebody who would have jurisdiction to sort out the mess in which grain transportation has found itself in western Canada?

Hon. Otto E. Lang (Minister of Transport): Mr. Speaker, that subject did come up at the senior transportation meeting which I chaired in Ottawa last week. I think there was a strong feeling among the participants at that meeting that much could be accomplished by some hard-hitting, direct contact in meetings like that, and that that might be preferable to putting another agency in position, even an agency under the name of controller. However, we did agree to meet again early in the new year, and I will certainly keep an open mind regarding the right solution, depending on what progress is made.

Mr. Murta: Mr. Speaker, the minister has indicated that he is favourably disposed to thinking about the whole question or the idea of a grain transportation co-ordinator with the power necessary at least to sort out some of the problems in the grain transportation industry at the present time.
