CRUISE MISSILE TESTING—STATEMENT ATTRIBUTED TO UNITED STATES AMBASSADOR

Mr. Derek Blackburn (Brant): Mr. Speaker, my question is for the Minister of National Defence. U.S. Ambassador Niles said last week, referring to the Cruise:

There was no danger in the tests to anybody. Sometimes they don't work, that's why you test them.

Does the Minister support the impropriety of an American official announcing a resumption of testing over Canadian territory before we have even had a report on why the last missile crashed?

Hon. Harvie Andre (Associate Minister of National Defence): Mr. Speaker, I have not seen all the report. I do not know what Ambassador Niles said.

As I indicated in an answer to the Hon. Member's Leader, the Canadian Government has to be satisfied as to the reasons for that crash. Once it is satisfied, the terms and conditions of the agreement entered into by the previous Government will be honoured.

REQUEST THAT MISSILE BE TESTED OVER UNITED STATES TERRITORY

Mr. Derek Blackburn (Brant): Mr. Speaker, in view of the fact that the cause of the second crash appears to be mechanical, pretty fundamentally mechanical, would the Associate Minister of National Defence tell the Americans, that from here on in, they should go back to the drawing board and then test or retest their Cruise missile over their own territory until at least they get the mechanical bugs out of it?

Hon. Harvie Andre (Associate Minister of National Defence): Mr. Speaker, the Hon. Member seems to have some information that is not available to me or to the Department of National Defence—

An Hon. Member: It would not be the first time.

Mr. Deans: That is nothing unusual.

Mr. Andre: —in that he seems to know what the reasons for the crash are.

Mr. Broadbent: We assume it was not God's will.

Some Hon. Members: Oh, oh!

Mr. Andre: The path for the test was chosen very carefully. There are all kinds of safety mechanisms to ensure Canadians and Canadian property are not damaged and are safeguarded. Those precautions remain in effect. I do not think there is any reason for the Hon. Member to try to scare Canadians in this regard.
