#### CANADA-U.S. FREE TRADE AGREEMENT

Mr. Nelson A. Riis (Kamloops—Shuswap): Mr. Speaker, it is my honour to present a petition on behalf of a number of residents of the fine City of Calgary, Alberta, as well as residents of Black Creek, Courtenay, Nanaimo, Cumberland, and Comox, British Columbia.

While they are different petitions, they deal with the same concern that the federal Government lacks a mandate from the Canadian people to conclude a trade deal with the U.S.

They believe that the deal would deny Canada the policy freedom to determine its own economic future and would undermine our ability to develop a society distinct from that of the U.S. Therefore, they ask Parliament to dissolve now to enable the people of Canada an opportunity to accept or reject the proposed trade deal during a national general election.

Mr. Rod Murphy (Churchill): Mr. Speaker, I also have the honour to present a petition signed by Canadians indicating their opposition to the Government's free trade arrangement with the U.S.

The petitioners believe that the trade agreement negotiated by the Government threatens the very fabric of Canadian political and economic sovereignty by removing the power of the Canadian Government to control foreign ownership effectively, to develop Canadian energy resources in the best interests of Canadians, and to equalize opportunities between the regions.

They humbly pray and call upon Parliament to dissolve and allow the people of Canada the opportunity to accept or reject the proposed trade arrangement through a national general election.

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, I have a petition signed by residents of Canada who now avail themselves of their ancient and undoubted right thus to present a grievance common to our petitioners, namely that the Mulroney Government has sold out Canada without obtaining anything in exchange; that Canadian industries are still not protected against U.S. trade laws; that the United States has obtained everything it wanted in major areas, including agriculture, energy, the automobile industry, financial services and the investment industry; that the jobs of thousands of Canadians are being threatened, and that the Conservative Government has failed to provide any adjustment assistance for Canadian workers.

Wherefore your petitioners humbly pray and call upon Parliament to condemn this Government for signing the Mulroney-Reagan trade deal.
