Report from Committee (with ten amendments), February 14, 1990; adoption of Report, as amended, and third reading (with nine amendments), February 21. Message from Commons agreeing with 4(a), amending 1, 4(b), (c) and (d) and 8, and disagreeing with the others; question and message referred to Special Committee on Bill C-21 (revived), March 14. Report from Committee (agreeing with 1 and 4(b) and insisting on the others) adopted March 20. Message from Commons agreeing with 5(b); disagreeing with 2(a), (b) and (c), 3(a) and (b), 5(a), 6, 7 and 9; amending 4(c), (d) and 8, May 10. Senate agreed to Commons amendments and did not insist on its amendments, October 22. Royal Assent, October 23. *Chapter 40, 1990.*
