HOPEWELL HILL.

Hopewell Hill, Oct. 30.—Stephen Beechin, Jr., was sentenced by Judge Wedderburn at the county court today, to one month in the county jail, with hard labor, for escaping from the custody of a constable. The jury's verdict was guilty, with a recommendation to mercy.

The judge, in referring to the Beechin matter, deplored the laxity and gross negligence of the constable, who had allowed the prisoner to leave him to get liquor, and even had provided the money for the purchase. His honor said that if he had had heard was true, the administrator of justice in the county, as carried out by the subordinate executive officers, was rotten to the core.

His honor's charge to the jury was a most lucid and eloquent presentation of the case.

Beechin will come up before the Supreme court in January, on another charge of escape.

In the review case of Bishop vs. Canling, a verdict was given plaintiff with damages, \$5.

The last case was ordered to stand over to the next sitting of the court, the accused having escaped from the county jail.
