## AIR TRANSPORT

SUGGESTED FLIGHT SAFETY COMMITTEE AUTHORIZATION OF FUNDS

Mr. J. M. Forrestall (Dartmouth-Halifax East): Mr. Speaker, in the absence of the Minister of Transport I wish to direct my question to whoever is acting in this capacity today. Can the Acting Minister say what reply has been made to the Canadian Airlines Pilots Association brief in which it is suggested that a national flight safety committee be established? Will the Acting Minister also say whether the Department of Transport has any plans to form a departmental flight safety committee, either internally or at the national level?

Hon. Robert K. Andras (Minister without Portfolio): Mr. Speaker, in the absence of the Minister of Transport I will undertake to refer the question to him. I understand the minister will be in the house tomorrow and will probably furnish the answer.

Mr. Forrestall: I wish to pose a further supplementary-I ask that notice be taken of it-to the President of the Treasury Board who is also supposed to be here today but is absent. In light of reports that the Department of Transport flight safety committee has not been formed because Treasury Board has not authorized funds, will the minister say what the intention of Treasury Board is in regard to this very important matter?

Hon. Eric W. Kierans (Postmaster General and Minister of Communications): I will be glad to bring that question to the attention of the Yukon is under study. No decisions have the President of the Treasury Board.
