

37. *Resolved*, That a sum not exceeding One thousand dollars be granted to Her Majesty, to defray the expenses of inspecting the Rivers and Mill-dams in Nova Scotia, for the year ending 30th of June, 1882.

38. *Resolved*, That a sum not exceeding Four hundred and one dollars and thirty-nine cents be granted to Her Majesty, to defray expenses in connection with the title of land occupied by the Magnetic Observatory, *Toronto*, for the year ending 30th June, 1882.

39. *Resolved*, That a sum not exceeding Four hundred and forty-nine dollars and eighty-one cents be granted to Her Majesty, to defray expenses in connection with arrears of rent in connection with building occupied by the *St. John* Observatory, for the year ending 30th June, 1882.
