Mr. Dallas moved, seconded by Mr. G. Wilson,

That the Rules and Regulations now read be adopted.—Carried.

Moved by Mr. Dallas, seconded by Mr. Ross,

That the Rules and Regulations now adopted, be called the Standing Rules and Regulations of the Municipal Council of the District of Simcoe.—Carried.

Moved by Mr. Adam, seconded by Mr. Arnson,

That the Warden be instructed to order the Clerk to make application to the Home District Council for all papers and petitions belonging to the District of Simcoe.—Carried.

Mr. Adam gives notice that to-morrow he will move for the nomination of three fit and proper persons whose names may be sent to the Governor-General, that he may appoint one of them to be Clerk of the Municipal Council of the District of Simcoe.

Moved by Mr. G. Wilson, seconded by Mr. A. Wilson,

That a committee be appointed to devise a common seal for the Municipal Council of the District of Simcoe, and that Mr. Dallas and Adam do compose said committee.—Carried.

Moved by Mr. Adam, seconded by Mr. Arnson,

That a Standing Committee upon Roads and Bridges be appointed, and that said Committee consist of Messrs. Jeffs and Walker.—Carried.

Moved by Mr. Dallas, seconded by Mr. Carswell,

That a Standing Committee on Finance and Assessment be appointed, and that Messrs. Ross and G. Wilson do constitute the same.—Carried.

Moved by Mr. Arnson, seconded by Mr. Garbutt,

That a Standing Committee on Education be appointed, and that Messrs. Garbutt and Carswell do compose the same.—Carried.
