*Ordered*, That the Order of the Day for going into Committee of the whole House, in consideration of Supplies to be granted for the Public Service, be discharged, and stand as the Order of the Day for Thursday next.

Mr. S. Humbert moved for leave to bring in a Bill, to prevent unnecessary expense and delay in the administration of Justice.

Leave granted.
