ORCHARD WAS **HUMAN BUTCHER**

The Paid Assassin Con- Hampton N. B. Also Visited Inquest On South Mountain Is Watching The Agricultinues His Revolting

Defense Tries to Discredit Half Business Section Of Conflict Of Evidence In He Will Extend The Idea The Evidence Against Haywood

Boise, Idaho, June 8.—Counsel for

Boise, Idaho, June 8.—Counsel for Wm. D. Haywood continued their attack on the testimony of Harry Orchard at both sessions of the trial yesterday. They made their strongest assault on the witness' connection with events beginning with the explosion in the Vindicator mine and ending with the earlier meetings between him and the leaders of the Western Federation of Miners in Denver. To the extent that traffic with "the other side" in the war between labor and capital in Colorado was discreditable, they succeeded in discrediting the witness.

Taking up the admission that Orchard made in direct examination that he was treacherous to his comrades in Cripple Creek by disclosing a train-wrecking plot, they developed that Orchard entered the employ of D. C. Scott, who had charge of the railway detectives. Orchard said that, with Scott, he met K. C. Sterling, a detective in the employ of the Mine Owners' Association, and that Scott paid his expenses and accompanied him to Denver on the trip when he first met Moyer and Haywood. He said that he had agreed to report to Scott, but that he lied to him, never intended to report to him, and never did report. The defence also tried to show that, because he stood well with the mine owners, Orchard was never molested by the militia in Cripple show that, because he stood well with the mine owners, Orchard was never molested by the militia in Cripple Creek during the strike. Orchard ad-mitted that Scott had told him that if the militia interfered with him he was to send for him, and that the militia did not interfere with him nor search his house.

nor search his house.

Orchard Secame Jealeus.

Orchard said he went to Scott first because he had not been paid for his work at the Vindicator mine, and he was jealous because he was given hard work like the Vindicator mine job, whereas other men were assigned the simple job of train-wrecking by displacing rails. More crimes, great and small, were added to Orchard's record yesterday. The Cripple Creek woman with whom he committed bigamy had three sons; Orchard stole high-grade ore from a measmate; he stole two cases of powder from the Vindicator mine; he stole powder to make one of the bombs thrown into the Vindicator coal pile, and he lied.

der from the Vindicator mine; he stole powder to make one of the bombs thrown into the Vindicator coal pile, and he lied.

The defence endeavored in various ways to throw doubt and improbability around Orchard's whole Vindicator mine story, and the alleged connection of W. F. Davis and William Easterly with the affair, and the circumstances under which Orchard testified that he met Moyer and Haywood, and was paid for the commission of the crime. It also tried to discredit Orchard's story, that he was sent back to Cripple Creek with unlimited credit and orders to commit any act of violence that he cared to. They confronted Orchard with Easterly and Owen Barnes and paved the way for the contradiction by them of the story told by Orchard.

Counsel flared up several times during the day, and in the last passage at-arms Mr. Hawley said that Mr. Richardson told a falsehood when he intimated that Orchard was a fixed witness.

When Orchard again took the stand yesterday he said he had neglected to give the name of his sixth sister. Minnie Horsley, who married a man named Rogers and who lived in New York State. Orchard also said that he stated Thursday he had no partners in the wood business in Burke, Idaho. He remembered yesterday that there were two men to whom he owed money and to whom he had promised an interest in the business. Orchard admitted that while he was in Idaho he became quite a gambler, playing poker most of the time. He was asked how he voted the day the unions decided to go down to Wardner and blow the Bunker Hill and Sullivan mills, and said he didn't remember.

E. F. Richardson, for the defence, took the witness through a description of the make-up of the train which took the rioting miners to Wardner. Orchard said it was composed of 13 cars, some being freight and others passenger coaches.

"I am sure," he said, "I lit one of the fuses which fired powder under the mill."

A BIG FIRE AT ELMVALE

The blaze started in Vance's tailor shop, but before it was noticed it had such a good start that the bucket brigade was unable to stay its progress.

The total loss will be about \$45,000 and incendiarism is suspected.

WAS TASHWAR MURDERED?

Farmer Opened Yesterday

Mysterious Case - Suicide Suspected .

Southampton, June 8.—The adjourned inquest on the death of the late James Taushway was begun yesterday in the town hall here. A tremendous crowd was in attendance and in their efforts to get in the hall almost mobbed the officials.

W. C. Whittaker, M.D., of North Williamsburg, coroner, had charge of the inquest, and Crown Attorney James Dingwall of Cornwall acted for the crown. Provincial Detective Reburn of Toronto is assisting the case.

Mrs. William Major, a niece, heard Taushway say he was a disgrace to his friends and always would be so. These words appeared to her to mean that he had committed suicide.

Albert Taushway swore positively that the quilts were drawn up over the shoulders, and thought that his brother had met foul play.

Thomas Taushway, another brother, told his story, and was pretty well questioned by Crown Attorney Dingwall. He told about the same story as the others, except that he had seen Taushway drawing a large amount of money in bills. He thought that it was suicide, because deceased had told him that he would like to show the people that he had courage enough to blow out his brains.

Dr. Porter created a sensation by swearing that it was impossible, as far as he knew, for deceased to kill himself in the position found. He had performed the post-mortem, and thought death was instantaneous. Therefore, it was impossible for Taushway to pull the quilts up over his shoulder after the shot. The bullet fround in Taushway's brain was placed in evidence.

Dr. Ferrier was a little more emphatic in his opinion regarding the case as murder.

The doctor who performed the autopsy says Macdonald did not drown, as there was no water in the lungs.

The bridge has a low railing, and it is thought that as the night was dark he may have made a misstep and fallen over, but some fear that there has been foul play, although there is no evidence that there had been robbery committed. An inquest is being held.

Too Many Electrocuted. Buffalo, June 8.—District Attorney Abbott has begun an investigation into the death of Warner Houck, a telephone lineman, who was electrocuted yesterday. Houck was splicing the loose ends of a telephone wire, which came in contact with an electric light line. He was instantly killed.
