Teachers Appreciate the Canadian Government Annuities Scheme.

The teachers in the public schools must as a rule, themselves provide against the day when their age or infirmities will demand their retirement from their profession, and many, it is understood are alive to this fact and are taking advantage of the provisions of the Government Annuities scheme to secure a competency for later years. The number doing so is perhaps small in proportion to the large number engaged in teaching, but it must be borne in mind that the Annuities idea is new, and that the attention of the school teachers has only been recently specially directed to it. Many might follow the example of a woman in one of our cities. She was 43 years of age, had no heirs, and her salary over and above her weekly expenditures was laid away to keep her in the days when the shadows began to lengthen. She had saved \$1,000. It was drawing 3 per cent. compound interest, or increasing at a little better than \$30 a year. heard of the Government Annuities scheme, and she immediately transferred her \$1,000 to the Government on account of the purchase of an Annuity payable at age 60. Having no heirs she purchased on plan "B", and the Annuity which a payment of \$1,000 secured for her at 60 was \$222.60. But shortly after her \$1,000 had been paid to the Government she became an invalid and was tatally incapacitated from performing her duty. Her case came under the provision of the Act which proon account of the purchase of an

vides that if invalidity or disablement occurs a person, if he or she has paid in sufficient to secure an Annuity of not less than \$50, may draw the Annuity though then under 52 years of age. The payment which she had made gives her an Annuity of \$69.67 so long as she may live. If the period before she became disabled had been 5 years she would have had an Annuity of \$88.50, and at 55 she could have had her contract converted into an Immediate Annuity of \$147.50. It will, therefore, be seen that if she could avail herself of the provisions of the Act at any time after her March 6th at 10 a.m.
\$1,000 had been paid, she would drain. have had an income over twice as large as she would have received had she left the money in the Savings Bank. This illustrates the advantage of persons who have been laying up for their old age transferring their savings, or a portion of them, to the Government on account of the purchase of an Annuity.

The coming of the Duke of Connaught to Rideau Hall must be regarded as a tribute to Canada's growing importance. The Crown being the chief link of Empire, and the King himself being fully employed in Great Britain, it seems only fitting that the only other available member of his family should represent the monarch in his chief over-sea dominion. The appointment is really a just recognition of Canadian autonomy. It stamps the Empire afresh as a series of equal States. As the London Morning Post puts it, fifty years hence Canada may be the wealthiest, most populous and most powerful division of the Empire, nd then the King may reside at Ottawa and send governor-generals to Westminster. This is an aspect of the Duke's selection that should appeal to Canadians everywhere and fire their pride anew in the Imperial connection. As for the Duke himself he turned out to help defend Canada against the Fenians, and he is personally popular with the large numbers of Canadians who have come in contact with him. He is acceptable alike to English and French Canadians, and will be accorded a warm welcome when he reaches this country.
