THE Y. P. S. C. E. of Bishop's Mills, Ont., at a business meeting held on Jan. 12th inst., unanimously voted out of their treasury \$15 to the Students' Missionary Society of Queen's College, Kingston. The Endeavor Society is in a healthy condition both spiritually and financially.

Toronto Churches.

KNOX CHURCH.

Seldom has the yearly meeting of Knox church been so largely attended or so unanimous and enthusiastic as that held in the lecture hall of the church. Rev. Dr. Parsons, the pastor, presided. The report of the session showed a membership of 655 in good standing. Notwithstanding the depression in trade, the revenue of the church for all purposes amounted to \$12,868.88, made up as follows:—Congregational collections, \$3,567.50; seat rents, \$2,226.35; ground rents, \$4,622.35; collected specially for the poor, \$822.25; Dachess street mission, \$57; Women's Foreign Mission, Topp Auxiliary, \$302.19; Willing Workers, \$57.80; Happy Gleaners, \$124.86; pastor's class, \$233.31; Sabbath school scholars, \$526.16; Duchess street mission, Sabbath school, \$265 and the Ladies' Benevolent Society. \$53.33. The expenditure included \$2,462, paid to the various church schemes authorized by the General Asembly. The expenditure for church maintenance, pastor's salary, and other items was about the same as in previous years. The members present made a very hearty response to the appeal for funds to make up the deficiency. The prospects for the year are exceedingly good. The only officers to be elected were the trusters, and those retiring were re-elected by acclamation. They are Jas. Scott, chairman; A. J. Somerville, secretary; Paul Campbell, treasurer; Chas. Cockshutt and Hugh Macdonald.

OLD ST. ANDREW'S.

There was a very large attendance at the annual meeting of the congregation of Old St. Andrew's church. The session presented their report, showing that 54 members have been added during the year, 31 had removed to other churches, and eight died, making a gain of 15. The membership is now 516. The managers reported that the revenue was \$7,376.57, leaving a surplus to the credit of the floating debt of \$194.88. By the Ladies Aid, \$50.50, and by special collections \$58.35, were raised, making a total of \$165.85 for benevolent purposes. For this purpose the Ladies' Aid gave for city relief \$10, nursing at-home, \$10, Toronto city mission \$10, and 149 articles of clothing for Needle Work Guild. The amount raised for schemet of the church thus far, through the various agencies of the congregation, is \$2,281.13. The total for year is \$11,020. It is expected when all sums are in for the year that the total will reach fully \$12,000.
