## USE OF NET SOCIAL BENEFIT RATHER THAN GROSS NATIONAL PRODUCT AS INDICATOR OF PROGRESS

**Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce):** Mr. Speaker, in reply to a question asked on Tuesday by the skeptical member for Edmonton West I wish to inform him that Statistics Canada—the Dominion Bureau of Statistics—is as I assumed, looking into that matter. There is widespread interest among statisticians, I am informed, in the possibility of developing a set of “social accounts” which might provide in a different sphere the sort of logical structure—obviously, I did not write this—which the “national accounts” and “gross national product” have provided for many years.

The topic is under study by the statistical agencies of the OECD and the United Nations, and the Dominion Bureau of Statistics is participating actively in this work. Thus far the project has been exploratory. At the moment, a senior officer of DBS is at meetings in Europe on the matter.

So, obviously NSB was something quite well known among enlightened people.

## RAPESEED—REPRESENTATIONS FROM JAPANESE IMPORTERS RESPECTING POSSIBLE INCLUSION UNDER WHEAT BOARD

**Hon. Otto E. Lang (Minister of Manpower and Immigration):** Mr. Speaker, I have received a number of wires from sources, including sources in Japan, on this subject but also broadly related to the question of the rapeseed market. In some cases it was not easy to tell whether their concern was about the suggested closing of the Vancouver futures market which had been contemplated by the Winnipeg Grain Exchange or some other steps being taken or whether it was the result of the erroneous report about the bill which was given initially. I have also received telegrams from them two months ago on the general subject of the problems they were having with the rapeseed market, following which there was action on our part in conjunction with the rapeseed association and the Winnipeg Grain Exchange to correct the situation.

## POTATOES—ASSISTANCE TO PRINCE EDWARD ISLAND GROWERS
