SUGGESTED CONSTRUCTION OF OIL PIPELINE TO MONTREAL—CONSULTATION WITH PROVINCES

Hon. Alvin Hamilton (Qu'Appelle-Moose Mountain): Mr. Speaker, my question is directed to the Minister of Energy, Mines and Resources and refers to the statement of the Prime Minister. In view of the announcement of the Prime Minister that the government intends to build an oil pipeline to Montreal, has the government consulted the provinces of Quebec, Ontario and Alberta in relation to the complexities and problems about volume, supply, markets and price?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, in the discussions we have had with all the relevant provinces, as a result of the energy analysis, we broached with them among other things the security of supply problem for the eastern Canadian market and, particularly with the officials of the province of Quebec, considerations that might lead to the construction of the pipeline into Montreal. I should say that the particular problem that is contained in the Prime Minister's statement was, of course, not discussed although it was communicated to the relevant provinces before the statement was made in the House.

SUGGESTED CONSTRUCTION OF OIL PIPELINE FROM SAULT SAINTE MARIE TO MONTREAL—GOVERNMENT POSITION

Hon. Alvin Hamilton (Qu'Appelle-Moose Mountain): I have a supplementary, Mr. Speaker. My question is still for information. In the minister's answer earlier he mentioned the pipeline from Montreal to Toronto. Now, I am asking whether the plan to build a reversible pipeline through Sault Sainte Marie, the northern route to Montreal, is abandoned?
