DISPOSAL OF OLD BARGES IN LAKE OKANAGAN—POSSIBILITY OF HAZARD TO ENVIRONMENT OR RECREATION

Mr. John A. Fraser (Vancouver South): Mr. Speaker, my question is directed to the Minister of the Environment. In view of the answer given yesterday by the Minister of Public Works that the three derelict barges disposed of by the department by sinking them in Okanagan Lake are not a hazard to navigation, will the minister assure the House that these barges do not constitute a hazard to either the environment or the recreational use of Okanagan Lake?

Hon. Jack Davis (Minister of the Environment): Mr. Speaker, we are checking into the matter and if the barges are a hazard either in respect of navigation or to the environment we will take appropriate action.

Mr. Fraser: Mr. Speaker, I would like to ask the minister whether he can assure the House that the government has established procedures to ensure that acts of this nature will not be repeated until they have first received consideration by the Department of the Environment as to whether such acts are a contravention of Section 33 of the Fisheries Act of Canada?
