REQUEST FOR PROGRAM TO ASSIST YOUNG PEOPLE WISHING TO BE FARMERS

Mr. Stan Schellenberger (Wetaskiwin): Mr. Speaker, my question is for the Minister of Agriculture. In view of the fact that capitalization costs for young farmers have increased by 66 per cent in the past ten years and young farmers cannot always get Farm Credit Corporation loans or afford 10 per cent plus interest rates, will the minister be announcing a program soon to help young farmers stay on the farm or get started in farming?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, the record shows that more young farmers have received farm credit loans this year than for many years. We are working on a program. We will be meeting with our provincial counterparts to discuss this program on how we can aid more young people who really want to enter farming or remain in farming to do that.

CANADIAN NATIONAL RAILWAYS

OPERATION AT LOSS BY SUBSIDIARY, GRAND TRUNK RAILWAY, OF COMMUTER SERVICE BETWEEN PONTIAC AND DETROIT, MICHIGAN
