CIVIL ACTION BY CAPTAIN OF "GREENPEACE III" AGAINST FRENCH GOVERNMENT—ASSISTANCE BY CANADIAN GOVERNMENT

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, pursuant to Standing Order 26, I ask leave to

move a motion for the adjournment of the House for the purpose of discussing a specific and important matter requiring urgent consideration. I have given you a lengthy document with my reasons and I will not go through that document now. My only point is asking for this debate on the *Greenpeace III* is that the trial of Captain McTaggart will begin on May 12.

There is urgency in considering the matter now because this government has stated it will give him assistance, but he is not getting the assistance required. Also, we have the statement by French officials that there was collusion between the French government and the Canadian government in the boarding of the *Greenpeace III*. I think we should have an opportunity to debate this matter in the House before the trial of Captain McTaggart takes place, in order that he will have the weight of the support of the Canadian government at his trial against the French government.

Mr. Speaker: Order, please. As the hon. member has indicated, he has given the Chair notice of his intention to move the adjournment of the House pursuant to Standing Order 26. While it is customary to indicate that notice has been received, in this case there is some problem with the notice. However, were there not I should point out to the hon. member that I would have no difficulty in ruling that this is not a proper subject for debate under Standing Order 26.

In so saying, may I indicate that notwithstanding the importance of the subject—and, quite frankly, hon. mem-
