or by officials of the Prime Minister's office and in either case would he indicate to the House when this review will be finished and whether or not it will be tabled or made public in another way.

Hon. James Richardson (Minister of National Defence): Mr. Speaker, the forces structure review is taking place at the present time. It is in three phases. The first part deals with the tasks to be performed by the Canadian armed forces. The second part deals with the level at which these tasks will be performed and the third phase will deal with support services and costs. It will be only after we have completed the third phase that we will be able to make any public announcements or changes of direction for the forces.

Mr. Forrestall: Mr. Speaker, I wonder whether the minister would indicate if he made representations to the Minister of Finance in connection with the forthcoming budget concerning an increase in allocation of funds to meet many of the problems the Department of National Defence is now facing.

Mr. Richardson: Yes, Mr. Speaker; I make representations to my colleagues for more funds for the armed forces.

In light of the fact that the Prime Minister recently rationalized the aggressive sale of Canadian reactors all over the world on the ground that we have a moral obligation to promote energy sources in less well-off countries, would the minister tell us why the government is having a discussion with Iran about a CANDU reactor when Iran happens to be one of the richest countries in the world in energy.

Hon. Allan J. MacEachen (Secretary of State for External Affairs): Mr. Speaker, I do not accept the premise of the hon. member's question and therefore I cannot deal with it.

Mr. Gillies: Mr. Speaker, could the Secretary of State for External Affairs tell us why Canada is negotiating with Iran with respect to the sale of a reactor to that country?

Mr. MacEachen: Mr. Speaker, I am not so sure that negotiations are taking place at the present time.

Mr. Gillies: Mr. Speaker, inasmuch as the report of the Atomic Energy Commission in relation to countries we are dealing with says we are negotiating with Iran, will the minister indicate the reason this is going on?
