I have not yet received the findings of this review, Madam Speaker, and contrary to the hon. member's statement, present circumstances are not likely to improve because of such remarks.

# MR. MACGUIGAN—CORRECTION OF ERRONEOUS STATEMENT

Hon. Mark MacGuigan (Secretary of State for External Affairs): Madam Speaker, I rise on a point of order. I regret that I inadvertently misled the House yesterday afternoon in replying to a question from the Leader of the Opposition (Mr. Clark) concerning U.S. representations with respect to the national energy program.
